Flynn on behalf of the City of Elsberry for a police station at 106 North Third Street, Elsberry, Missouri 63343. The Mayor is also authorized to carry out and perform the terms of this agreement on behalf of the City, including executing all necessary authorizations and other documents required to carry out the terms of the agreement. The terms of the Lease are attached to this Ordinance.

Bill 2022-04-002

AN ORDINANCE OF THE CITY OF ELSBERRY, MISSOURI, TO PROVIDE FOR THE CREATION OF CITIZENS ADVISORY COMMITTEES, PROVIDE FOR THE APPOINTMENT AND REMOVAL OF THE COMMITTEES' MEMBERS, AND PROVIDE FOR THEIR DUTIES AND RESPONSIBILITIES, BY ADOPTING A NEW CHAPTER 37 TO THE CITY MUNICIPAL CODE.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ELSBERRY, MISSOURI AS FOLLOWS:

SECTION 1. The Elsberry City Municipal Code is amended to adopt a new Chapter 37 as follows:

CHAPTER 37 — CITY ADVISORY COMMITTEES

§37.010. ESTABLISHMENT OF CITY ADVISORY COMMITTEES.

The Mayor, or a Majority of the Elected Aldermen, may propose the establishment a one or more citizen advisory committees. Such Committees may consist of citizens residing within the City limits, or within the boundaries of the Elsberry R-II School District, or who own businesses within those limits and boundaries..

§37.020. PURPOSES.

- 1. An citizens advisory committee may be created for a specific purpose, or it may have a general scope. The purpose of such committees is to share information between the residents of Elsberry on matters of public concern and to assist the City in fulfilling the City of Elsberry's mission statement. At the request of the Mayor or the Board of Aldermen, a citizen advisory committee may review and provide a recommendation on a topic or issue.
- 2. Nothing contained in this Chapter shall give a citizen advisory committee any power, either directly or indirectly, to exercise any authority, direction or control over City property, monies or any employee thereof.
- 3. Nothing contained in this Chapter shall give a citizen advisory committee the authority to make any changes to any ordinances, policies, practices or procedures of the City.

§37.030. MEMBERSHIP.

- 1. The number of members, and their qualifications, for an Elsberry citizen advisory committee shall be established by executive order of the Mayor, or by separate Ordinance, upon the creation of the citizen advisory committee.
- 2. The Mayor, or the Mayor's designee from time to time, shall be an ex officio member of each such citizens advisory committee and shall be entitled to be present, vote, and participate in all meetings of each such citizens advisory committee.

§37.040. TERMS AND APPOINTMENTS...

1. The length of the terms of each member of an Elsberry citizen advisory committee shall be established by executive order of the Mayor, or by separate Ordinance, upon the creation of the citizen advisory committee.

- 2. Members will be appointed by the Mayor, subject to the confirmation of the Board of Aldermen.
- 3. After the initial appointment of committee members, appointments shall be made annually at the first regular meeting of the Board of Aldermen after the annual Municipal Election, or as soon thereafter as practicable.
- 4. Whenever a vacancy in membership occurs, the City Clerk shall notify the Mayor and the Board of Aldermen of the vacant position, and the vacancy may be filled for the unexpired term by appointment. The Mayor or the Board of Aldermen may remove any member by a majority vote of the Board of Aldermen.
- **§37.050. Conduct of Meetings**.1. The committee will be guided by Robert's Rules of Order, 10th Edition, as revised, and the Missouri Open Meetings and Records Law, as amended.
- 2. Meetings may be called by the Mayor, a majority of the Board of Aldermen, or the City Clerk.
- 3. The agenda for meetings shall be established by the Mayor, a majority of the Board of Aldermen, or the City Clerk.
- 4. A majority of the members appointed to citizen advisory committee shall constitute a quorum.
- 5. The Mayor may assign staff members, or City contractor personnel, to attend meetings of a citizen advisory committee.
- 6. Meetings of a citizen advisory committee shall be noticed and conducted in accordance with Chapter 610, RSMo. All meetings of a citizen advisory committee shall be open to the public unless otherwise authorized by law
- 7. Each citizen advisory committee shall designate one (1) of the citizen members of the committee as its Chairman. The Chairman shall be appointed for a term of one (1) year to expire at the first regular meeting of the Board of Aldermen after the annual Municipal Election or until a successor is appointed and duly qualified. The Chairman shall preside at all meetings of the citizen advisory committee.
- 8. Each such citizen advisory committee shall be responsible for keeping copmplete and accurate minutes of its meetings and shall provide the City Clerk with a timely copy of those minutes.

§37.060. Members Shall Serve as Volunteers on Various Committees.

Each member of a citizen advisory committee shall serve without compensation, and without reimbursement of expenses, except for expenses specifically approved by the Board of Aldermen in advance of the expense being incurred.

SECTION 3. SEVERABILITY.

The provisions of this Ordinance shall be severable. In the event that any provision of this Ordinance is found by a court of competent jurisdiction to be unconstitutional, the remaining provisions of this Ordinance are valid unless the Court finds the valid provisions of this ordinance are so essentially and inseparably connected with, and so dependent upon, the void provision that it cannot be presumed that the Board of Aldermen would have enacted the valid provisions without the void ones or unless the Court finds that the valid provisions, standing alone, are incomplete and incapable of being executed in

accordance with the legislative intent.

SECTION 3: EFFECTIVE UPON PASSAGE

This ordinance shall be in full force and effect from and after the date of its passage.

SECTION 4: INCORPORATION INTO THE MUNICIPAL CODE

The City Clerk shall incorporate the terms of this Ordinance into the official City of Elsberry Municipal Code with all due dispatch.
