Mrs. Beck is asking that the entire bill except for 1000 gallons be abated for the current bill and next months bill. Alderman Taylor said that the property owner should be responsible.

INTRODUCTION AND READING OF BILLS FOR PASSAGE

The board considered Bill 2021-12-001

AN ORDINANCE OF THE CITY OF ELSBERRY, MISSOURI, TO AUTHORIZE THE CITY MAYOR OR THE MAYOR PRO TEM TO EXECUTE CITY CEMETERY DEEDS ON BEHALF OF THE CITY

WHEREAS, from time to time the City of Elsberry ("the City") sells burial plots in the City Cemetery that require an authorized signature by a City official on the Cemetery Plot Deed to complete the transaction.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ELSBERRY, AS FOLLOWS:

SECTION 1. The Mayor of the City of Elsberry, or the Mayor Pro Tem of the City of Elsberry are each authorized to execute City Cemetery Plot Deeds on behalf of the City.

SECTION 2. Severability. The provisions of this Ordinance shall be severable. In the event that any provision of this Ordinance is found by a court of competent jurisdiction to be unconstitutional, the remaining provisions of this Ordinance are valid unless the Court finds the valid provisions of this ordinance are so essentially and inseparably connected with, and so dependent upon, the void provision that it cannot be presumed that the Board Aldermen would have enacted the valid provisions without the void ones or unless the Court finds that the valid provisions, standing alone, are incomplete and incapable of being executed in accordance with the legislative intent.

SECTION 3. Repeal of Conflicting Ordinances. All ordinances and resolutions, and parts of ordinances and resolutions, in conflict herewith are hereby repealed.

SECTION 4: Effective upon Passage. This ordinance shall be in full force and effect from and after the date of its passage.
