READING OF BILLS REQUIRING ONLY A FINAL READING FOR PASSAGE None

INTRODUCTION AND READING OF BILLS FOR PASSAGE

The board considered Bill 2022-03-001

AN ORDINANCE OF THE CITY OF ELSBERRY, MISSOURI, TO PROVIDE FOR REQUESTS FOR CITY WATER METER RE-READS AND DATA LOG SERVICES, AND SETTING THE FEES FOR SUCH REQUESTS AMENDING SUBSECTION 110.090.1 OF THE CITY MUNICIPAL CODE AND BY ADDING A NEW SECTION 110.120 TO THE CITY MUNICIPAL CODE.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ELSBERRY, MISSOURI AS FOLLOWS:

SECTION 1. The Elsberry City Municipal Code subsection 110.090.1 is amended to read as follows to increase the disconnection fee from \$85 to \$100:

"110.090 DISCONNECTION AND RECONNECTION FEES AND COSTS.

1. The City Collector is authorized and empowered to levy and collect an administrative charge of One Hundred dollars (\$100.00) from each User whose City utility service has been disconnected for violation of this Code or non payment of Utility charges. This fee shall be assessed and collected for each time the service is disconnected

SECTION 2. The Elsberry City Municipal Code is amended by adding a new §10.120 as follows:

"110.120 RE-READ AND DATA LOG REQUESTS – FEES AND COSTS.

- 1. If a User of City water or sewer utility services believes that the User's City water meter is not accurately reading water usage, or suspects that the User's water lines may have a leak, that User may make a request to the City Collector to re-read the User's City water meter.
- 2. The User requesting a re-read service under Subsection 1 above, shall pay the City a fee of Fifty Dollars (\$50.00) for the re-read service, with payment to be made to the City in advance of the re-read.
- 3. If a User of City water or sewer utility services believes that the User's City water meter is not accurately reading water usage, or suspects that the User's water lines may have a leak, that User may make a request

to the City Collector to perform a data log summary of the User's City water meter.

- 4. The User requesting a data log service under Subsection 3 above, shall pay the City a fee of Fifty Dollars (\$50.00) for the re-read service, with payment to be made to the City in advance of the re-read.
- 5. The fees charged pursuant to Subsections 2 and 4 above will be waived under the following conditions:
 - a. The request is made for a Residential Unit; and
 - b. The User's is questioning the User's latest water bill which is at least One Thousand (1,000) gallons over the User's previous three months average for that Unit; and

c. The User has not made a request for the re-read or data log in the previous three months

6. If it is determined that the water bill that the User is contesting is in error due to the City's error, the service fee for the re-read or data log for the erroneous bill will be refunded to the User."

SECTION 3. SEVERABILITY.

The provisions of this Ordinance shall be severable. In the event that any provision of this Ordinance is found by a court of competent jurisdiction to be unconstitutional, the remaining provisions of this Ordinance are valid unless the Court finds the valid provisions of this ordinance are so essentially and inseparably connected with, and so dependent upon, the void provision that it cannot be presumed that the Board of Aldermen would have enacted the valid provisions without the void ones or unless the Court finds that the valid provisions, standing alone, are incomplete and incapable of being executed in accordance with the legislative intent.

SECTION 4: EFFECTIVE UPON PASSAGE

This ordinance shall be in full force and effect from and after the date of its passage.

SECTION 5: INCORPORATION INTO THE MUNICIPAL CODE

The City Clerk shall incorporate the terms of this Ordinance into the official City of Elsberry Municipal Code with all due dispatch.

Alderman Taylor made a motion to read bill 2022-03-001 2 times by title only.

Alderman Miller seconded the motion.
