put them if we need to move them. He can call Jackson's Automotive to see if they can move them. Mayor Short asked Chief Davis to find out what is in the storage units that we can get rid of. Rob Guinness said that he has photos of all the evidence that is being stored and he can work with the Chief to catalog and decide what needs to be destroyed.
