**JOSEPH PALMER LIBRARY**

Members of the Page Branch Park Committee met on the evening of the above date at the Joseph R. Palmer Family Memorial Library, 7:00 pm. Present were, Amy Lowe, Jo Ann Cordsiemon, Kimber Cordsiemon, Curtissa Kerr Hunter, Mike Short and Sarah Hunt. Khrista Cooper was absent.

**CALL TO ORDER**

Chairman Lowe called the meeting to order. Roll call deemed a quorum present.

**AMENDMENT TO AGENDA**

Mr. Short moved to amend the agenda to add discussion of the issues with the pedestrian bridge and retaining wall replacement using FEMA/SEMA funds under 'project update'. Motion was seconded by Mrs. J. Cordsiemon. Vote was as follows:

**OLD BUSINESS**

SPLASH PAD DESIGN-Mrs. Hunt explained that prevailing wage is not required for the Splash Pad project but e-verify for contractor employees is. Mrs. Hunt also noted that she is requesting proposals for the project.

**NEW BUSINESS**

FUNDING FOR SPLASH PAD-The Committee was advised by Mrs. Hunt, Mrs. J. Cordsiemon and Mrs. K. Cordsiemon that People's Bank and Trust will be donating \$10,000 for naming rights of the splash pad. This announcement will not be made public until a later date.

**PROJECT UPDATES**

FEMA/SEMA FUNDING FOR REPAIRS/REPLACEMENT-Mr. Short led discussion regarding the consideration of refunding the FEMA/SEMA funds for the bridge and doing the work on our own. Currently, the bridge project is on hold as the allotted funding is not enough to cover the project. Completion of the Clean Water Act form is required with or without FEMA/SEMA funds. Following some discussion a motion was made by Mrs. K. Cordsiemon, seconded by Mr. Short, to move forward with the retaining wall and playground project with FEMA/SEMA funds, give back the \$13,000 allowed for the pedestrian bridge and file for the permit to follow through with the bridge project on our own. Vote was as follows:

NAYS-None                      Motion carried with 6 ayes, 0 nays.

Mr. Short also noted that the beams and planks have already been purchased. Mr. Short will take this vote to the Board of Aldermen for their consideration.
