#### New roof for city hall

Rob stated that he would not discuss liability in open session, but we could have waivers they could sign.

# **<u>Cell phone for Chief Davis</u>**

A few months ago, the Chief's personal phone was added to the Cities phone plan. Alderman Taylor said that he does not have a problem with this. We used to have phones for the police department but it was stopped because it was being abused. Alderman Rockwell asked for clarification on what exactly we were paying for. Chief Davis said that there was a phone that no one was using so he asked Sue Hogarth to switch the number to his personal number. Mayor Short states that this action was not authorized. Rachel Reed asked why should one department head get a cell phone when the rest of us do not? We all use our personal cell phones for city business. The Police Department can have calls forwarded to personal phones. City Collector Nicole Castleberry suggested issuing a credit for cell phone usage for city business. Alderman Rockwell suggested tabling until next month to try to come up with something fair for everyone. Mayor Short explained that we need to decide what to do about the current situation. The change was not authorized.
