

**CITY OF ELSBERRY
SPECIAL SESSION
BOARD OF ALDERMEN MEETING
MONDAY AUGUST 31, 2022 AT 5:30PM
ELSBERRY CITY HALL**

The Board of Aldermen of the City of Elsberry met on the evening of the above date at Elsberry City Hall at 5:30 pm. Mayor Short presided over the meeting. Present were Alderman Taylor, Alderman Rockwell, Alderman Wilch, Alderman Davis, Alderman Meyer, Alderman Harper, and City Clerk Rachel Reed.

Mayor Short called the meeting to order.

Public hearing as required by law or ordinance

The subject of the public hearing shall be the proposed rate of taxes for the calendar year 2022. In compliance with Section 137.055.2 RSMo, the County Clerk of Lincoln County has certified the assessed valuation of the City of Elsberry, Missouri as follows:

The tax rates shall be set to produce the revenues for the calendar year of 2022. Each rate is determined by dividing the amount of revenue required by the current assessed valuation expressed in cents per \$100 valuation.

Bill No. 2022-08-001

ORDINANCE NO.2022-08-001

AN ORDINANCE THE CITY OF ELSBERRY, MISSOURI SETTING LEVIES FOR PROPERTY TAXES FOR THE CITY OF ELSBERRY, MISSOURI, FOR THE YEAR 2022 GENERAL AND CEMETERY FUNDS.

WHEREAS, the assessed value of Real and Personal Property in the City of Elsberry, Missouri for the year 2022 has been certified by the assessor of Lincoln County; and

WHEREAS, a public hearing on the proposed 2022 tax rate has been held on August 30, 2022, following due public notice; and

WHEREAS, the 2022 tax rates set forth comply with Section 137.073 RSMo, and Article X, Section 22 of the Constitution of the State of Missouri;

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ELSBERRY, MISSOURI, AS FOLLOWS:

SECTION 1: There is hereby levied a tax rate of **\$0.4837** for each One Hundred Dollars (\$100.00) assessed valuation of all property, real, personal, and mixed, for the purpose of raising revenue for the General Revenue Fund of the City of Elsberry, Missouri, for the fiscal year 2022.

SECTION 2: There is hereby levied a tax rate of **\$0.1450** for each One Hundred Dollars (\$100.00) assessed valuation of all property, real, personal, and mixed, for the purpose of raising revenue for the City Cemetery Fund, for the fiscal year 2022.

SECTION 3: Levies herein established are based on an anticipated total assessed valuation of real property and personal property as stated in the attached notice of hearing which is incorporated into this Ordinance by this reference as though set forth in full.

SECTION 4: Severability. The provisions of this Ordinance shall be severable. In the event that any provision of this Ordinance is found by a court of competent jurisdiction to be unconstitutional, the remaining provisions of this Ordinance are valid unless the Court finds the valid provisions of this ordinance are so essentially and inseparably connected with, and so dependent upon, the void provision that it cannot be presumed that the Board of Aldermen would have enacted the valid provisions without the void ones or unless the Court finds that the valid provisions, standing alone, are incomplete and incapable of being executed in accordance with the legislative intent.

Section 5. **Repeal of Conflicting Ordinances.** All ordinances and parts of ordinances in conflict herewith are hereby repealed.

SECTION 6: Effective Upon Passage. This ordinance shall be in full force and effect from and after the date of its passage.

SECTION 7: Incorporation into the Municipal Code. The City Clerk shall incorporate the terms of this Ordinance into the official City of Elsberry Municipal Code with all due dispatch.
